I _ Credit given to Watfa / Chickenland

My claim towards Mr. Watfa / Chickenland was submitted by TLA at the High Court on 15th June 2012 :

A Credit has been given with a **principle amount of 77,000 Euro** on October 2011.

The **debtor Mr. Watfa / Chickenland** has NOT partially repaid any amount since **12th December 2012**.

Now there is still **35,000 USD, loss and damage, interest rate** and the lawyers fee **overdue by the Debtor Watfa / Chaickenland**.

Since December 2012 no activities in the “Credit-Case” have been observed. It appears all participated parties are idle: TLA-Lawyers, Justice of the High Court, plaintiff / Debtor Watfa and my trustees in Sierra Leone, Mrs. Emma Allen and Mrs. Esther Munu.

No reply on my correspondences (lack of communication) towards the TLA-Lawyers has been observed as well, since my face-to-face meetings end of May 2013.

II _ Fraudulent Counterclaim of Mr. Watfa / Chickenland

In April 2013 Mr. Watfa had brought forward a fraudulent” claim. Hence I travelled to Sierra Leone in May 2013 to follow up Mr Watfa’s “counterclaim”.

Mr Watfa’s false pretences are proven by a lot of witnesses, which one gave an affidavit about the proper hand over of the apartment and door keys (preview : www.GuB21.de/Watfa/watfa3.pdf, www.GuB21.de/Watfa/watfa11.pdf, www.GuB21.de/Watfa/watfa13.pdf) .

In addition Mr. Watfa tried to suborn a witness to testify NOT the truth in the court. However Mr. Mhd. gave a
